**SCRUTINEERING:** 0730 - 0845 (DO NOT BE LATE otherwise no guarantee of all runs).

Your car must pass scrutineering to be allowed on the Skid Pan. An inspection (similar to the annual registration check) will be carried out prior to Driver Briefing in the morning. Emphasis will be placed on good brake pedal, steering and no fluid leaks. Remove all loose objects from the interior and boot.

Auto Tests 1 and 2: 0900 – 1230.

Two tests set from the Motorkhana Handbook. Each driver will complete each test with a number of times according to time available. The Auto Tests will be carried on a wet track all day.
